We have extra funds as we are not paying Jon Ballard. So we would like to purchase 10 rolls of stamps and 1000 pre addressed postage paid forever envelopes.

The Highway Department report from Kevin Rinehart is that the mountain tractor needed some repairs; they are almost caught up. The team is still fixing other culvert in the town. We are helping Jefferson, then out turn and then Kortright. They will be putting gin a big culvert soon. They have permission to bring down the excavator that they want to buy. They got \$30k for the Robinson Broadhurst Foundation and the machine will cost \$59k in total. It is in good shape and clean. The John Deere has 3k hours and there is a lot of money in that rig, there have been a lot of issues. Cowan road/Clove Road- Don Thomases sent a note saying what a great job the Highway Dept has done.

LVDV update: the old Thompson house is now owned by the Knight family. They are doing construction on the garage with the intention of making it a "mother in-law suite". There is an engineer involved, along with Tomi Tompkins and Mike Cairns for inspections. It was suggested that they put in two lines so that there are not 2 lines from the house, in the event of one failing, they don't both fail, it is not approved yet, they have a scheduled meeting. They also found out that the pump was down for the hamlet and they had to use the spare form the Hobart garage, Emmons took the old one to see if it can be repaired. Another pump is going down, the pumps cost about \$16k a few years ago, he will talk to Emmons and get back to us, we may need to buy 2 pumps.

We have still not received any bids for the cemetery mowings, again John asked if we could get someone out there and go from there.
